The other deferred work item for February funding is Finish Carpentry for \$80,900 (Total increase to GMP in February is \$582, 800.

UF FP&C has received \$383,000 in additional funding for the project. This money can be applied toward the purchase of furniture, equipment or any item that can be moved from one building to another. This money will be utilized, but will not help cover the immediate construction costs, mainly drywall, that are critical to the project at the current time.

Change Order #1 will be issued by UF FP&C to CRCC for an increase to the GMP of \$300,000. This money will purchase the perimeter metal studs and keep the project moving until April. UF FP&C is confident the state will match funding in the amount of \$700,000 in July, but there is some possibility that this money will not be available until August. In order not to delay the job, money for the interior metal studs must be received by the 2nd week of April. There was discussion that the Owner is indirectly paying a penalty for phasing work as Subs increase their bid amount to cover phasing issues. Since this is a possible area of increased cost, and procuring money is already critical, UF FP&C will endeavor to secure needed funds from UF Foundation ASAP. UF understands and agrees that not receiving funding as originally agreed impacts the cost of the project and increased general conditions may also be required. CRCC also noted that delaying award of bid packages affects overall coordination (i.e. by postponing paint, CRCC loses ability to coordinate finish of structural steel).

Since CO #1 will be \$300,000 instead of the needed \$500,000, possible solutions are being considered to obtain money for the balance of the drywall package. The bidding/award for ceramic tile and paint work is a possible alternative to delay in order to fund the drywall. This will create \$100,000 of additional funding, leaving \$100,000 still needed. Coordination of all delayed work is a serious issue, therefore increased funding at the present is the best solution to the current need.

CRCC proposed several VE suggestions during the meeting, as described below. These suggestions are dependent upon approval by UF BCN.

- 1. Delete 3 pairs of 4' doors at the side of the lobby. This would result in a savings of approximately \$15,000.
- 2. Downgrade the thermal performance of the glazing on the north side of the building.
- 3. Delete the window from the MEP&F studio, as it is already partially blocked and no longer serves its original intended purpose.
- 4. CRCC noted that savings could be produced by deleting operable windows (\$300 each); UF rejected this idea due to LEED scoring.

- 6. Action Item 004.006, Metal Panel at Exterior, was closed and replaced by Action Item 005.005.
- 7. Action Items 005.001 through 005.008 are new items.
- 8. Attached to these meeting minutes are (1) UF funding spreadsheet and (2) CRCC bid summary spreadsheet.
