#### A Message From ...

#### Dr. Christopher Silver, Dean



Long before devices such as odometers or GPS, there was a traditional practice from the 1800s of using stones along roadways to mark distances traveled, hence the "milestone." The term milestone has evolved to connote an action or event that identifies some significant change, stage of development or transition. At UF and in DCP, this year has been replete with "milestones." In the first week of December, the UF community gathered to celebrate the inauguration of UF's 12th president, Dr. W. Kent Fuchs. The former Provost from Ivy League and land grant Cor-

nell University clearly indicated in his inaugural address the profound respect he has for the traditions of UF. But he also articulated a new vision, one emphasizing greater global engagement, a more diverse student body, and attracting and retaining even more distinguished faculty, all designed to elevate the university into the ranks of the top 10 (dare he say top 5) public universities. The vision plan being crafted by an appointed team of faculty and administrators, will serve as the roadmap to guide UF to that next stage of its development. President Fuchs appointment clearly is a campus-level milestone.

The term also applies equally well to happenings in our College and in the Rinker School. In case you missed the flood of email and newsletter stories, DCP is celebrating the 90th anniversary since it began as the School of Architecture in 1925. When we examine the history of how the School developed into the today's multi-disciplinary college focusing on all aspects of the built environment, the vision of the founding director, architect Rudolph Weaver, is paramount. Weaver insisted that if he came here as director, it must be for an independent School of Architecture. It was also Weaver who advocated through courses and curricula all of the main components of the future college, including not just architecture, but also building construction (which started in 1935), landscape architecture which started in 1933 (taken from agriculture), course on designing interiors, and even city planning all of which he insisted his design students should understand as part of their preparation for practice. Of course, this year has involved celebrating the Rinker School's 80th anniversary, but also quite importantly commemorating the contributions of Herman Block, who joined the School of Architecture and Allied Arts in 1949. He was inducted posthumously in the School's Construction Hall of Fame in recognition of his role in shaping the modern program and the professional credentialing of contractors in Florida.

The other milestone to report upon is the impending change in the administrative leadership of the College. This marks my tenth, and final, year as Dean of DCP. The university administration has assembled an esteemed search committee, including strong representation from the Rinker School, to conduct a national search for my replacement. For me, it is a milestone year, marking the closing of 23 years of academic administration at three different universities. To continue the community consulting started under the Florida Resilient Communities Initiative, continue our international engagements in Southeast Asia, especially in Singapore and in Indonesia where I have researched, consulted and taught continuously since 1989, and devote time to teaching and research, these are the new challenges that mark my transition back to a faculty role. Most important, I plan to continue to engage as much as I can with the fabulous alumni who I have developed friendships with over the past decade. For those of you in the BCN family that I have gotten to know and work with over the past decade, I thank you sincerely for your support to me and to the School. Thanks for making what might seem to some a tough job, one that has had so many wonderful moments.

#### Dr. Robert Ries, Director



The Rinker School has had a very active and accomplished 2015 that builds upon the school's tradition of leadership. The history and past accomplishments of the Rinker School include a key role in the formation of the accreditation body (the American Council for Construction Education or ACCE) and the accreditation standards for construction programs. Forty years ago, BCN was the first program accredited by ACCE. This past fall, the School was one of three pilot programs for a new set of accreditation standards that are based

not on a prescriptive "What are you teaching?" approach but on what students learn. Assessing what students are learning provides valuable input for refining the curriculum and the continuous improvement of the School. I would like to acknowledge Dr. Abdol Chini for his contributions to developing these new ACCE standards.

The accreditation visit included meeting with students, faculty, staff, alumni, and university administration. EXCOM was represented by David Brandon, Dale Hedrick, John Sofarelli, Wayne Wadsworth, Matt Webster, and Doug Wilcox. The draft report on the School's accreditation visit was very positive and will be reviewed by the ACCE Board of Trustees at the February ACCE meeting.

Company participation in the spring and fall 2015 Career Fairs reflect the recovering construction industry. One hundred and five companies participated in the spring 2015 Career Fair and one hundred and three participated in the fall. The job and internship market has been strong, which is a great benefit to our students. In fact, the graduating students in the last three semesters have all had 100% job placement before graduation. Students have also had very good success in obtaining internships that enhance their education through the Career Fair.

This past fall, the School's competition teams performed very well in the Associated Schools of Construction (ASC) southeastern regional competition and the Associated Builders and Contractors (ABC) national competition. The ASC design-build team placed first, and received a standing ovation along with the perennially successful DB team coach, Dr. E. Douglas Lucas. The ABC Construction Management team placed second nationally, a great accomplishment for team members Matt Cruitt, Matt Johnson, Melissa Morgan, Chris Nichols, and Evan Southern. Sincere thanks to the team sponsors who mentor and financially support the competition teams.

The Rinker School fall 2015 graduating class included 30 undergraduate, 11 masters, and one doctoral student. The fall 2015 incoming class consisted of 34 undergraduate students, 50 masters and 7 doctoral students. Enrollment is currently 251 undergraduates, 92 masters, and 32 doctoral students.

In Spring 2016, the School will be in the midst of a search for three faculty members that can bring their strengths in education and scholarship to the construction management program. Students are busy preparing for the spring competitions and faculty continue to improve the curriculum, publish their research, and write successful grant proposals. In other word, 2016 promises to be an equally active and accomplish year.

Private support of the Rinker School is essential to not only fund special projects but as a part of our annual on-going operating expense of our school.

The role and need for industry, alumni and Executive Committee support of the Rinker School continues to increase and evolve. We encourage the financial support and involvement of all our alumni through the BCN Advisory Council and each of our Regional Clubs. Our Regional Clubs are a great way to keep informed and stay involved with the School as well as network socially and professionally with your fellow alumni while providing a very important service to the School. #### **Construction Hall of Fame-**

The M.E. Rinker, Sr. School of Construction Management established the Construction Hall of Fame Award in 1980 to recognize the accomplishments of those distinguished leaders who have made a difference in our industry, the community and the University of Florida throughout their careers in construction. The inductees' names will be displayed on the "Hall of Fame Wall" of the School. We are honored to announce that Herman H. Block (posthumously) and John McIntyre were selected and inducted into the Rinker School's Construction Hall of Fame for 2015 at the Homecoming BBQ.



#### Herman H. Block

Herman H. Block joined the Building Construction Program in the Department of Architecture at the University of Florida to teach building construction courses in 1949. In 1956, he was appointed to organize the Department of Building Construction, which was formed in 1957. Dr. Block headed the Department of Building Construction until his retirement in 1963. During his time

as department head, he developed a nationally recognized construction education program which has been a model for many similar programs established at universities in this country and abroad. Dr. Block also set up a system of competency examinations for contractors known as Block examinations, which were administered by the firm H.H. Block and Associates in Florida and Georgia. Professor Block was also influential in the formation of the Building Officials Association of Florida, which provides education and training for building code officials.

Many Rinker almuni have relayed stories about their relationship with Professor Block and how he had a positive impact on their lives. Building Construction alumni and students honored him by establishing the H.H. Block Construction Education Fund in 1968 in recognition of his contribution to the construction industry and for his role in preparing hundreds of students for careers and positions of leadership in the construction industry. Professor H. H. Block passed away December 19, 1972.

#### John McIntyre

John McIntyre graduated from the University of Florida, School of Building Construction in 1984 and his first job was working for E.E. "Gene" Simmons General Contractor, Inc. in Sarasota, FL. In 1987, John co-founded his Company that has been in business 28 years – McIntyre Elwell & Strammer General Contractors, Inc. (ME&S). All of John's business part-



ners are also UF BCN Alumni. ME&S is a Sarasota based commercial building construction company that works primarily in the State of Florida and has also successfully completed construction projects in Georgia, Alabama, South Carolina, North Carolina, Kentucky and Tennessee totaling \$890 million.

ME&S currently employs 14 UF BCN Alumni and consistently places BCN Students every summer working in the internship program. John has also enjoyed returning to UF as a "Professor for a Day." 


#### Alumni working together-

#### **Porsche Design Tower**

The tower amenities include an elegant porte-cochere with 24-hour valet services, 24-hour security services and in-house car concierge, oceanfront lounge, lobby level bar and restaurant, wine room, spa, clubroom equipped with stadium seating theater, virtual golf and a four seat race car simulation video game. The common area interiors are being designed by Michael Wolk Design Associates of Miami.

During the summer leading up to my freshman year of high school, I was playing on three different baseball teams at the same time while also balancing odd summer jobs. I continued the trend of multiple sports, six a year, up until my junior year of high school. At that time, I decided it was best to focus on the sports that I felt played to my strengths in order to keep living the dream of being an athlete. The two sports ended up being baseball and distance running. I would run cross country in the fall and simultaneously play baseball and run track in the spring, often running before a baseball game or running home after. After finishing 6th at the state cross country meet and 2nd in the 3200 meter run at the state track meet, I began getting noticed by numerous colleges throughout the country. This solidified the fact that running was what I wanted to continue doing in college. During my senior year, I focused only on XC and track, setting the then state meet record of 15:02 for 5k in XC and also winning the state 3200m later that spring. I ultimately decided to attend the University of Florida on scholarship to run for one of the best track and cross country programs in the country under current head coach, Mike Holloway and then head distance coach, Jeff Pigg.

My freshman year of college was a real eye opener as to what it would take to succeed as a student-athlete at the University of Florida. Although the support system is huge, it takes a lot of responsibility and dedication to ensure that you are balancing all of the educational and athletic requirements. I believe balancing multiple sports at a young age helped with this tremendously. I was undecided my first three semesters

as to what degree I wanted to pursue. Once I figured out that the Rinker School of Building Construction was where I wanted to be, it was a huge relief. This feeling abruptly came to a halt when I learned that if I entered the program at that time, I would not be able to satisfy the NCAA requirements of meeting certain percentages of degree completion, which is taken into account each semester. I met with BCNs' Dr. Issa, and created a plan that would allow me to complete my undergrad degree with the Department of Geological Sciences and then enter the BCN Graduate Program. This worked out perfectly as I had redshirted



indoor track and would be looking to compete in my fifth year. Fast forward to the summer of 2010, I had completed three semesters of the graduate program and was looking to graduate at the end of the fall semester. Once again, my academic pursuits were having a curve ball thrown at them. I finished my athletic eligibility as an All-American in cross country, finishing 20th at the NCAA meet, a three time all SEC and South Region team member, a US Junior National runner-up finish in the 10k on the track, the UF school record holder for 8k and 5 mile distances in cross country and being a part of the 2010 NCAA Indoor and 2010 SEC Outdoor Championship teams. It was clear to me that I wanted to continue competing as a distance runner and was presented with the opportunity to join a post-collegiate Olympic Development Team. Due to the fact that this type of opportunity is hard to come by in the sport of distance running, I decided to put my last semester at BCN on hold and my wife and I moved out of town. I competed for the team for 3.5 years, the last year and a half as a satellite athlete when we moved back to Gainesville so that I could finish my degree. I graduated in the spring of 2013 and was able to land a job here in Gainesville with BBI Construction Management and it has been nothing short of amazing. I currently compete as a satellite athlete for the Saucony Hurricanes and will compete in my second Olympic Trials for the marathon next February.

I consider myself truly blessed to have earned a degree from and competed for one of the best universities in the country. The experiences, guidance, and education that I received assist me each and every day and I will be forever grateful for each and every person that played a part along the way. GO GATORS!

#### Richard "Rick" Coble, BCN 1992

Dr. Richard ("Rick") Coble was born on August 17, 1946, in Pasadena, California. He attended California Polytechnic University-Pomona, where he received his bachelor's degree in civil engineering. Rick worked in his father's construction business in southern California until an opportunity arose to work on the initial construction of Walt Disney World in Orlando.

In 1976, he started his own construction company, Kaco Construction, and worked on the Circus

World theme park, doing all of the site work and underground construction and constructing all of the buildings. Kaco also worked on several Epcot pavilions. While running his own construction company, he earned his master's degree in building construction at the University of Florida

In 1992, Rick was one of the first persons to receive a Ph.D. from the University of Florida College of Architecture. He became a professor in the UF Building Construction School, where he taught for 12 years and was named "teacher of the year." He was a visiting professor at the University of Salford in Manchester, UK and at Tsinghua University, Beijing, China. He loved all sports and was an avid Gator fan, collecting all sorts of Gator memorabilia.

Rick is survived by his two brothers, five children, and eight grandchildren. Rick often said that, "the only thing we leave behind is what we leave in others." He passed away on September 13, 2015.


#### Morris Trimmer, BCN 1962


